OLDER WOMEN IN COHOUSING INC - WINC

Last month Older Women in Cohousing Inc – WINC – reached a major milestone when Mount Alexander Shire Council voted unanimously to grant our project a permit.

Woo Hoo!

After 7 years of years planning, meetings, raised hopes and knockbacks, our vision to create a sustainable, accessible and mixed tenure 31-home co-housing community for older women to grow old joyfully together is another step closer to being built in Castlemaine.

This is the result of many years of dedicated work by WINC members and support from our outstanding professional colleagues.

Although our permit approval is incredible exciting, we still have a way to go. We have to raise substantial funds to help cover the purchase costs of 5 of our homes that will be offered to eligible WINC members as social housing. We also need more money to support our 'middle women' – WINC members with too many assets to be eligible for social housing and too few assets to buy a home. We established our Middle Women Housing Fund to cover the gap for these women to buy a WINC home.

After we take some time to celebrate our achievements to date, we will then get on with the important task of fundraising to ensure that women of all asset levels can live together at WINC.

TENANTS RIGHTS

Thanks to those attendees at the Tenants Rights Forum last month who have joined our Tenants Rights working group. We aim to:

- Support all voices equitably in a coalition manner which supports renters in Mount Alexander Shire.
- Build awareness of tenants' rights amongst tenants, landlords and real estates/property development networks.
- Advocate for affordability across a broad scope of potential new frameworks for tenants.
- Advocate for and assist with information on improving rental energy efficiency,
- Advocate for structural change so that renters have equitable access to affordable renewable energy
- Build awareness of energy efficiency rebates, subsidies and other incentives for landlords so that tenants may be comfortable in their homes

We are keen to hold tenants rights information stalls in our Shire building on raising awareness of tenants rights, supports and compliance to those rights.

We continue to work with <u>Renters And Housing Union</u> (RAHU), <u>Housing Justice</u> and the Residential Tenancy Commissioner and are encouraging tenants to engage with the State Government to improve accountability of real estates and landlords.

HOMESHARE



October has been an exciting Homeshare month as we welcomed the HANZA Board to Castlemaine last weekend. HANZA wanted to meet face to face with the working group, Dhelkaya staff and community members to discuss what we had learnt from our 12 month establishment phase. They are very keen to spread the word about our community led Homeshare model because they can see it has the community connections required to last the lengthy establishment phase required of Homeshare developments.

Homeshare Mount Alexander continues to learn how to develop Homeshare in this community setting.

We regularly receive expressions of interest from keen Homeseekers, looking for more affordable rent and wanting to develop relationships and companionship with Homeproviders. We have not been able to provide matches to all of them because Homeprovider applications have not kept up.

Our plan to encourage more homeproviders includes refreshing the messaging, advertise more, involve more community champions or ambassadors for Homeshare to get more reach as well as create more regular activities for people to come together to talk about the experience of house sharing at any age. We don't assume that sharing a house is without adjustment but we do know that practice is a good idea especially as we know that as we age our mobility will reduce along with our ability to connect outside our houses.

We have developed a summary guide to a THOW contract/agreement between a THOW occupier and the owner of the land and permanent dwelling where the THOW is located.

We reckon there are more than 50 families who are building THOW or living in THOW after the local law changes last year.

MOUNT ALEXANDER REFUGEE SUPPORT (MARS) UPDATE



As many of you know we welcomed a Syrian family to Castlemaine on 10 September through the Community Refugee Integration and Settlement Pilot (CRISP).

Mahmoud, Lava and their three children, Lareen, Yahia and Elina, had flown from Iraq. They were very happy to have arrived in Australia after years of upheaval and danger.

Over many months MARS and many of you in the Shire of Mount Alexander community have contributed time, money and goods, musical performances and good will. It has been a wonderful experience of community caring.

We found temporary accommodation for the family; completed all the paperwork and bureaucratic rigmarole necessary to enable them to receive Centrelink payments, health care cards, Medicare cards and a TFN; arranged full health assessments and vaccination catch ups at the Refugee Clinic at Bendigo Community Health Service; provided information about school options and what to expect at Australian schools.

MOUNT ALEXANDER REFUGEE SUPPORT (MARS) UPDATE (CONT.)

Above all we gave them a warm welcome, Lava and Mahmoud were grateful and rather surprised at the level of support. We have really enjoyed getting to know them and learning to use google translate.

Castlemaine is a wonderful community as we all appreciate, but there are very few Arabic speakers or people from Syria. Quite early on Mahmoud and Lava expressed concerns about the children and their sadness at not being able to speak Arabic with other children. The family felt welcome but isolated. They spent some time considering other options and were able to make contact with someone they knew in Wollongong. After some consideration they made the decision to move.

MARS has assisted in planning the move and a successful transition from the CRISP program to the Humanitarian Settlement Program (HSP) was organised. A Red Cross case manager was allocated before they left Castlemaine. Temporary accommodation was sourced with the assistance of the Red Cross. Health support has been sourced from a Refugee Health Service nearby. Their Syrian contact arranged to meet them at the airport. On 3rd October we said goodbye, sad to see them go, but happy that they have made a decision that feels right for them. We wish them good luck and a successful life in Australia.

A decision as to what we do next will be made in the coming weeks. Remaining funds will go to supporting refugees through the CRISP program.

VACANT DWELLINGS

Our discussions with owners of vacant dwellings have resulted in nine vacant dwellings released as affordable rentals, 3 shop tops released as affordable rentals and three as transition housing.

VACANT DWELLINGS (CONT.)

One property owner encourages others to join her, saying

"Offering this kind of affordable rental is just such a simple, but life-changing way to be part of a community. We reckon houses are for living in. And ours is lived in and cared for, while the reduced rent covers our outgoing costs. We worked all this out directly with the resident/tenant, who we connected with through the local grapevine. She's fantastic and we really value the relationship we've got with her."

We will be requesting a meeting with Council to discuss sending letters to Mount Alexander Shire residents requesting those owning vacant dwellings to consider releasing them as affordable rentals or transition housing.

HOUSING FOR ELDERS

Di Cox, Homeshare coordinator and i participated in the Seniors Festival Expo and presented on options for elders in our Shire trying to downsize or seek appropriate housing as they age. Data that informs the need for appropriate diverse housing for our elders include:

- In our Shire we have nearly double the Victorian average % of elders -28% over 65 and Vic average is 16%
- 744 people over 75 live alone 500 of them women.
- 11% Australians live in rentals at 55 years (the most precarious of all renters as they can't absorb rent increases)
- What compounds the lack of affordable housing for our elders is the mismatch of supply and demand- in Mount Alexander Shire we have 33.2% single person households but only 2.4% one bedroom dwellings.

Di and I talked about Homeshare, Tiny Homes On Wheels, secondary dwellings, housing trusts, intergenerational collective housing models, social housing and building on affordable long term rentals.

SOLAR BANK

A local group of interested people are developing a proposal for the new State Electricity Commission (SEC) that a local Solar Bank be built and installed on suitable State Government School, Hospital, Prison and Council roofs in our Shire.

Local renters could then lower their energy bills by buying a subsidised share in the SEC shared Solar Bank and pay for it over time at no up-front cost.

In exchange for the energy generated by their leased solar panel shares, participating renters would receive discounts on their SEC electricity bills.

There are nearly 1500 rental households in our Shire who don't not have the same access to affordable solar energy and haven't had for the last twenty years. We have gathered support for this proposal from a diversity of local government and community organisations.
